3. Asset Allocation

Staff provided an update on the Asset Allocation analysis. Staff and Meketa discussed the IAC's preference for a proposed allocation that reduced the Safety Reserve from 15% to 9% and increased the Global Equity allocation from 40% to 50% with the Board at the May and June Board meetings and received direction to review additional mixes that are closer to a market weight to Emerging Markets Equity. Staff recommended an implementation plan to complete the 6% reduction to the Safety Reserve by the end of 2021 and reallocate approximately equal amounts in Global Equity, Emerging Market Equity and Emerging Market Debt. Staff intends to seek Board approval at the July 8th Board meeting.
